With a deadline of May 25, 2018, the EU's General Data Protection Regulation (GDPR) requires companies to significantly change the way they store, manage, share, and transfer all of their data. Consequences of not complying – or being unable to prove that a compliant strategy is currently being put in place – can result in fines of up to 4% of annual turnover.
